- \_\_\_\_\_ *I understand that the role of the "Vikings Row Together" Tuition-Based Pre-K Program is to provide a classroom environment with peer models for the Early Childhood Special Education (ECSE) students who are able to model age appropriate communication, social, and self-help skills.*
- \_\_\_\_\_ *My child is toilet trained. Lago Vista ISD defines toilet trained as wearing underwear (not pull-ups) and able to request to use the restroom. If an accident occurs, my child is able to change clothing and clean up with minimal adult assistance.*
- \_\_\_\_\_ *My child is able to function in a 1:6 adult to child ratio.*
- \_\_\_\_\_ *I understand that I am responsible for ensuring that my child's immunization requirements are met prior to enrollment.*
- \_\_\_\_\_ *I understand that this is an educational program and that my child must remain at the school for the full school day (7:45-3:20pm) in accordance with the Lago Vista ISD school calendar.*
- \_\_\_\_\_ *I understand that tuition payments for the "Vikings Row Together" Tuition-Based Pre-K Program must be paid through automatic, electronic draft each month. Further, although every effort is made to keep the schedule for bank drafts, it is expected that sufficient funds will be available if the account is drafted at a later date.*
- \_\_\_\_\_ *I understand that my child must follow the policies and procedures outlined in the Lago Vista ISD Student Handbook and the Lago Vista ISD Student Code of Conduct and that if my child has persistent behavior problems that interfere with the general welfare of others, my child may be temporarily or permanently removed from the program.*
- \_\_\_\_\_ *I understand that the decision to withdraw my child from the "Vikings Row Together" Tuition-Based Pre-K Program must be communicated to the campus principal, in writing, one month in advance.*
- \_\_\_\_\_ *I understand that if I decide to withdraw my child from the "Vikings Row Together" Tuition-Based Pre-K Program, it is my responsibility to cancel the authorization agreement for preauthorized payments (electronic bank draft) by notifying the Lago Vista ISD Business office, in writing, one month in advance.*
- \_\_\_\_\_ *I understand that if a child is withdrawn from the "Vikings Row Together" Tuition-Based Pre-K Program for any reason after attending one day of class in a month, no refund will be given for that month.*
- \_\_\_\_\_ *I understand that tuition payments for the "Vikings Row Together" Tuition-Based Pre-K Program are due on the first school day of the month, in accordance with the schedule provided in the information packet.*
- \_\_\_\_\_ *I understand that Lago Vista ISD will assess a \$35.00 fee for any declined payments/returned checks.*
- \_\_\_\_\_ *I understand that Lago Vista ISD will assess a late fee of \$10.00 per business day for tuition payments received after the first school day of the month.*
